Ms. Mills,

I just read an email that you had sent my mother earlier this past week, with ridiculous terms for a meeting. and frankly find it insulting and suppressive as a sex crime victim.

The idea for a meeting was originally suggested by you via a text message to me on 7-28-20. At the time it felt disingenuous to me due to your husband Mr. Sadat's threatening letter the evening before.

Over time I was willing to give Lee a chance to hear how he effected my life, but the bullying conditions you are now trying to put on a sex crime victim during their meeting to confront their abuser shows me how disingenuous Mr. Stobby's request apparently was.

Respectfully, I find your conditions quite insulting as I am the one who was the victim of a sex crime and I will not have my voice suppressed and remove any posts just to be granted an audience with my sexual predator (an audience that he/you had asked for).

Politely but firmly, this is not my shame to carry, and I will not indulge Mr. Stobby's arrogance by complying to his demand that his sex crime victim keep quiet simply because it is inconvenient for him. It was inconvenient for me for him to prey on me and for my life to be dismantled and upended as a result, as I'm sure that same fate would also be inconvenient for any possible future victims Mr. Stobby may have (hence why I spoke out). In my opinion it ultimately was Mr. Stobby who inconvenienced himself by exposing me to HIV without my consent.

I was altruistically willing to take a zoom meeting, with friends that I trust in attendance as witnesses, as a "MADD Panel" (Mothers Against Drunk Driving, where DUI defendants listen to family members talk about losing loved ones to drunk drivers) of sorts so that Lee could know the true damage he wreaks when he commits sex crimes. I was willing to let Mr. Stobby have friends in attendance too, so long as they were willing to answer questions about whether or not they were aware of his behavior (he appears to have had friends such as John Hillary Shepherd shadow me online).
